Conditions to be followed by the College/Institute/Academy:

1. The College has to appoint six (06) faculty members, through duly constituted selection committee as per OU norms, by associating the University Nominee on the Selection Committee and Subject Expert.
2. The College has to strengthen BTK, QTK and other Labs.
3. The College has to establish ATK Lab as per norms.
4. Governing Body meetings are to be conducted thrice in a year by associating University representatives.
5. The Teaching and Non-teaching staff salary payments have to be made through Bank is Mandatory.
6. The College has to maintain Teaching Diaries and Student Attendance Registers properly.
7. The College has to depute the faculty for Refresher Courses/Orientation Programmes/Faculty Development Programmes, conducted by Osmania University/Other Institutions.
